RESOLVED to note the action taken on the minutes of the last meeting of Board of Management, held on 22<sup>nd</sup> December, 2016 and expressed satisfaction over the same.

#### MPUAT/BOM-47/ 2017-01/03

To re-consider the decision taken by the Board of Management in its meeting held on 18th March, 2011, vide Resolution No. MPUAT/BOM-29/2011-01/05, in the matter of Dr. Ravi Kumar Sharma, Professor, Department of Civil Engineering, College of Technology & Engineering, for governing him under Old Pension Scheme.

In view of ruling of State Government, *RESOLVED* to withdraw the Order No. F. MPUAT/Estt/Gr. I/2011/2200-8 dated 24<sup>th</sup> / 25<sup>th</sup> March, 2011, issued in the matter of governing Dr. Ravi Kumar Sharma under Old Pension Scheme and hence he will be governed in the University under New Contributory Pension Scheme only.

#### MPUAT/BOM-47/ 2017-01/04

To consider the request of Sh. Ashok Verdia, Dairy Plant Operator, College of Dairy & Food Science Technology, Udaipur, for withdrawing the minor penalty of 'Censure' imposed upon vide Order No. F. 427/RAU/Estt/Gr. II/98/10674 dated 19/20.11.1998.

RESOLVED that in view of repeated acts of indiscipline by Sh. Ashok Verdia, Dairy Plant Operator, he was imposed minor penalty of 'Censure', which now cannot be reviewed. Hence, his request cannot be acceded to and accordingly, the minor penalty of 'Censure' imposed upon him cannot be withdrawn.

#### MPUAT/BOM-47/ 2017-01/05

To consider executing a bond / agreement by the newly appointed teachers and officers to the effect that they will have to serve the University at least for a period of five years from the date of joining in the University, failing which they will have to deposit a sum of Rs. 300,000/- in lieu of bond period.

RESOLVED to approve the proposal that a teacher/officer, newly appointed in the University, shall have to execute a bond/agreement, on a non-judicial stamp of Rs. 100/-, to serve the University for a period of five years in the University, failing which he/she will have to deposit a sum of Rs. 300,000/- in lieu of bond period.

Further *RESOLVED* that in future, no application shall be forwarded for outside posts of any organization, within a period of five years from the date of his/her joining in this University, for equivalent posts.
